PROPOSAL CONTENT

1. Theme is free and the submitted works have been preferably done in the last two years.
2. FOTONOVEMBRE will accept a maximum of 2 proposals by participant.
3. **Proposal report:** it must be specified its concept, kind of work: photo (total number of works), video or performance, and technical data and conditions for its installation.
4. **Visual documents:** a selection of eight (8) photographs maximum (per proposal), black and white or colour, which give a general idea of the exhibition project and make it possible to understand it globally. They should have a minimum resolution of 300 dpi, biggest size 21 cm, tiff or jpg format.
5. **Biographical curriculum.**
6. Other useful information (press reviews, catalogues, etc)
7. Proposals will be sent by e-mail, separately (one per e-mail), **8 Mb maximum** per sending, to the following email: centrodefotografia.tea@tenerife.es

8. They may also be sent by **Wetransfer**.
9. Proposals will be **deleted** three months after the end of this edition.

10. Deadline: they will take part in the selection all the works sent until 24 h, local time, **07/05/2019**.
11. Results will be published from **03/06/2019**, in the websites www.fotonoviembre.org and www.teatenerife.es
12. Deadline for the delivery of the press material of the selected proposals is 21/06/2019.
13. Works ready to be exhibited, must be received in TEA - Centro de Fotografía, 27/09/2019 the latest.

14. Among all the received proposals, five will be selected, whose authors will form the section “**Artistas en Selección**”, one of which will be chosen as an “**Artista en Selección – Fundación MAPFRE Guanarteme**”
15. The authors selected to take part in the section “**Artistas en Selección**” will receive four thousand euros (4.000 €), subject to the withholding tax which legally corresponds, for production and temporary cession of works (for their exhibition).
16. Those proposals not included for this section, may be chosen to be part of the section “**Atlantica Colectivas**”, for which a partial production fund will be established that will be distributed by venues.
